Description of Requested Change:

In June 2009, the T2S AG approved the proposal of the Subgroup on Process Efficiency (PESG) on T2S non-mandatory matching fields. The PESG proposed to differentiate the non-mandatory matching fields based on matching principles and proposed the exhaustive list of settlement-related T2S non-mandatory matching fields.

Reason for Change / Expected Benefits / Business Case:

The implementation of the proposal will provide T2S Users with additional clarity and transparency on T2S matching facilities and principles.

5.5.3 Additional Non-mandatory matching fields

Additional Non-mandatory matching fields

T2S shall support non-mandatory matching fields. Non-mandatory matching fields are fields in the settlement instruction that T2S matches when they are present. There are two types of non-mandatory matching fields:

- Additional matching fields are fields that are not mandatory but become mandatory when at either one of the counterparts to the settlement provides a value for them in its instruction
- Additional Optional matching fields are fields that are not mandatory but that become mandatory when at least one of the two both settlement counterparts completes provide a value for them in its their instructions.

A <u>The</u> non-exhaustive list of these additional optional matching fields can be found in the table below.

Annex 2 Glossary and Standards

Title	Definition	Remark
T2S additional matching field	a non-mandatory matching attribute of a settlement instruction, which becomes a mandatory matching criterion when either of the parties to a settlement instruction provides value for the attribute. T2S additional matching fields cannot match with a field with no value (null value).	
T2S optional matching field	a non-mandatory matching attribute of a settlement instruction, which becomes a mandatory matching criterion when both parties to a settlement instruction provide a value for the attribute. T2S optional matching fields may match with a field with no value (null value).
